
# EDITOR'S MESSAGE

# Dental Gubernaculum

Ten years ago, I could not tell you what the dental gubernaculum was. But, after my mentor, Norman Thomas, DDS, MD, PhD, asked me to assist him on some research, I learned about it and of its importance to all of dentistry. The paper was published in the JCDA, Aug, 2014.

As dentists, we learn a lot just to get through dental school. We learn a lot of things that we did not know before we started! If we knew what we needed to know to be a dentist before starting dental school, what would we do? Would we have spent more time watching television or playing video games?



## Sugar can damage the gubernaculum. Now you know! So what?

Many dentists have told me that upon graduation, they felt like they had learned everything about being a dentist – until they started practicing dentistry. Thus, begins the many hours of continuing education, usually beyond what is required to maintain our dental license.

There are very few specific topics required during each licensure period. Most of the required hours are at the discretion of the dentist as long as they meet the requirements for the dental board. Each dentist has their own interest or self-determined need for the CE topics they prefer to take – and, that is their right to choose. However, do we know enough about what we need?

When I was in law school many years ago, (Just to learn more about law - not to become an attorney.), I came across some interesting cases. In one a general dentist was sued for poor results of an RCT. The patient held that she thought the dentist was a specialist and had she known, she would have gone to a specialist to do her RCT. But, she saw all of his CE certificates on his walls for endodontics. I've also seen cases where the board will discipline the dentist and dictate that they take a certain number of CE hours on topics the board feels the dentist needed. Both of these dentists must have felt they knew enough about dentistry and were taking CE classes on topics in which they had an interest.

#### You don't know what you don't know!


I hope the day does not come where the board makes specific requirements on the topics for each license renewal period – and, I have never heard of that even being considered. (However, the topic of "recertification," where health care practitioners are required to re-take examinations, has raised its ugly head from time to time!)

Tri-County Dental Society provides a variety of CE courses. The CE committee attempts to find topics and presenters that the dentists will not only enjoy but learn important information. Over the years many topics have been published in our TCDS newsletter for those who wish to learn more from recent research. Many members have mentioned to me at meetings that they enjoy finding things they enjoy learning more about. Of course, if it is a topic they do not care to check out, they can skip on to the next topic. The digital version of the Connection has made this much easier with just clicking on the links. Some information has been provided from the ADA or CDA publications.

The ADA publishers have found that less than 10% of members read their publications and ask that their material also be published in local society publications.

With the introduction of the new TCDS website, <a href="www.TCDS.org">www.TCDS.org</a>, it will now be possible to post the research abstracts and the other ADA, CDA, information for members to peruse and be able to check back on previous posts. This will also help reduce the size of the Connection newsletter and reduce the cost of publishing.

I encourage all members to seek information to improve your practice and your life. I hope we all can continue to learn more than what we know today. (FYI: The dental gubernaculum is a ligament that helps pull the teeth into the mouth. Sugar is detrimental to this and can possibly result in malocclusion, craniofacial deformities, TMD, sleep disorders, diabetes, CVD, Alzheimer's, and early death. Therefore, advise parents to control sugar in a child's diet.) So, when you choose what topics you wish to learn more about, consider the saying, "You don't know what you don't know."



#### WHAT RIGHTS DO PATIENTS HAVE IN ACCESSING THEIR RECORDS?

You own the patient record, including X-rays. Patients and their legal representatives are entitled to view or have copies of their information. You may require that the patient submit a written request and you must verify the identity of the requestor. A HIPAA-covered entity must provide an electronic copy if a patient requests that format. The patient's entitlement to a copy of all treatment records may not be denied due to the presence of sensitive information in the records or because of an outstanding balance. After receiving the request in writing, you have 15 calendar days to deliver the copy to the patient. Should a patient ask to inspect his or her record, you have five working days to provide access. In addition, if a summary of the record is requested in writing, you have 10 days to provide the summary to the patient. Never release original content of the chart or original X-rays to the patient or any other health care provider. Failure to provide records to a patient when requested is a violation of the Dental Practice Act and can subject you to a fine and payment of attorneys' fees if the patient is forced to compel production of such records.



# In Memoriam

#### Bruce Otto Lensch, DDS. June 2, 1934 – August 30, 2022

Tri-County Dental Society member for 58 years and past TCDS president in 1973-74, Dr. Bruce Otto Lensch, age 88, passed away on Tuesday, August 30, 2022. He is survived by Audrey, his wife of 64 years.

Bruce graduated from USC in 1960 and served in the US Air Force before starting his practice in Chino in 1963 and joining TCDS. He practiced in Chino for many years and was properly held in high esteem by his colleagues and his patients. I knew him as one of my landlords for my Chino practice - and as a friend. Bruce loved working with organized dentistry. Of course, he loved his wife Audrey even more as they were married in 1958. As many spouses of officers in organized dentistry, she sacrificed her time with him and shared his life of dentistry.

Bruce held various positions in the many organizations he participated in – both dental and civic. He served as a Chino City Councilman for several years, President of the Chino Kiwanis Club, President of Immanuel Lutheran Church and President of the Chino Civic Center Authority. Before becoming President of the California Dental Association in 1983, he served as President-Elect, Vice-President, Secretary, Treasurer, and Delegate to CDA's House of Delegates. He served USC Dental School as an instructor, assistant and associate professor, and obtained the rank of clinical professor. He had served in 1973-74 as President of the Tri-County Dental Society, Chairman of the Board of Oral Health America, and a Regent of the International College of Dentists.

One of Dr. Lensch's activities in the International College of Dentists was that he held the position of Regent, representing California. Upon learning of Bruce's passing, Dr. Leighton Wier, long serving and current ICD Regent from Texas wrote *this*:

hanks for letting me know about Bruce. I enjoyed serving with him for two years when I first joined the Board of Regents. I took an immediate liking to him, and soon developed a lot of respect for him. He always came to the meetings well prepared, spoke to the issues with acumen, and always tempered his remarks with a touch of humor. He was one of the most respected Regents. I encouraged him to run for the vice president position, but he decided the timing was not right for him to commit to another 4 plus years of service. I always remember when he gave me a package of trail mix and said to me, "This is a treat from the land of fruits and nuts."

Fellow, Bruce O. Lensch was honored at the 6th Annual ICD/ACD Spring Awards Dinner Dance in 2007 in Anaheim with the Lifetime Contribution to Dentistry Award and Excellence in Dentistry Award.

Bruce received many awards in his years of service. He also received the California AGD Dentist of the year award in 1985.

Bruce was a member of several dental organizations including the American College of Dentists, and served as a Fellow of the International College of Dentists, and Pierre Fauchard Academy.

Bruce was a prime example of a professional practitioner sharing his time to help our profession grow , and improve in helping our fellow humans in this world. I know that his whole family and those who knew him were very proud of Bruce and will miss him greatly.

A memorial service to celebrate his life was held on October 8, 2022, at 11:00 a.m., at Immanuel Lutheran Church located at 5648 Jefferson Avenue, Chino, California. Bruce's final resting place will be the Riverside National Cemetery in Riverside, California.

# **NEEDLESTICKS**

### HOW TO REDUCE RISKS AND COMPLY WITH OSHA

Imagine you are working with a patient, you reach for an instrument, and feel something sharp. You are bleeding and realize you just had an *EXPOSURE INCIDENT*.....or your employee says "OUCH, I just got stuck!". Do you know exactly what to do to prevent infection transmission and comply with the OSHA Bloodborne Pathogen Standard?

Dentists Insurance Company (TDIC) needlesticks are the number one type of injury that occurs in a dental office. When needlesticks involves contact with patient fluid, it is considered an exposure incident. An exposure incident can also occur when splashes of blood or body fluid reach the employee's eyes, nose, mouth, non-intact skin, and from human bites.

When an exposure incident occurs, immediate action must be taken to expedite medical treatment for the exposed employee to prevent infection transmission. Exposure to blood and body fluid carries the risk of contracting Hepatitis or Human Immunodeficiency Virus. So to protect employees and comply with the **OSHA Bloodborne Pathogen Standard**, safety plans must be in place and reviewed annually.

Dentists are required to establish a written Exposure Control Plan (ECP) and conduct training on it annually. The ECP is designed to help employees identify, minimize and eliminate risks of exposure to potentially infectious materials in the workplace. In addition, the ECP must contain information for the employee on what to do when an exposure incident occurs, who to report to, and where to go for post-exposure medical evaluation. Your ECP should be located in your office OSHA manual. Members of the California Dental Association can access a downloadable Exposure Control Plan from the CDA **Practice Support Website**. Or you can locate an **Exposure Control Plan** on the CAL/OSHA website.

The ECP requires personalization. This means fill in the blanks to establish policies and procedures based on your own workplace. Examples on personalizing your ECP include: instructions on what personal protective attire to wear, policies on handling contaminated items, and what steps to take in the event of an exposure incident.

Create a personalized exposure incident protocol and review it at your next morning huddle or staff meeting and again at least annually. You can use the sample plan provided (in table 1) and add details specific to your office. Specific details include: who to report to, what healthcare provider will be used, where the first aid kit and eye wash station are located, where the required OSHA accident forms are, and how to obtain employee medical records, including vaccination status.



#### **Sample Exposure Incident Plan**

- 1. Provide immediate care to the exposure site.
- If exposure is the result of splash, flush mucous membranes with water.
  - · Wash wounds and skin with soap and water.
- Take instrument involved out of action so it does not get used on the patient!
  - · Employee must report incident immediately to supervisor/employer
    - 2. Determine risk associated with exposure by
- Type of fluid (e.g. blood, visibly bloody fluid, or other potentially infectious fluid or tissue).
- Type of exposure (e.g. percutaneous injury, mucous membranes or non-intact skin exposure, or bites resulting in blood exposure).

#### 3. Evaluate exposure source

- Assess the risk of infection using available information.
- The source individual (patient) must be asked if they know their Hepatitis B, C, or HIV status, if not known, will they consent to testing.
- 4. The exposed employee is referred as soon as possible \* to a health care provider who will follow the current recommendations of the U.S. Public Health Service Centers for Disease Control and Prevention recommendations for testing, medical examination, prophylaxis and counseling procedures.
  - Note "ASAP\*" because certain interventions that may be indicated must be initiated promptly to be effective.
  - The exposed employee may refuse any medical evaluation, testing, or follow-up recommendation. This refusal is documented.
    - 5. The employer must send all of the following with the exposed employee to the health care provider:
      - A copy of the Bloodborne Pathogen Standard.
  - · A description of the exposed employee's duties as they relate to the exposure incident. (Accidental Bodily Fluid Exposure Form)
  - · Documentation of the route(s) of exposure and circumstances under which exposure occurred. (Accidental Bodily Fluid Exposure Form).
  - All medical records relevant to the appropriate treatment of the employee including HBV vaccination status records and source individual's HBV/HCV/HIV status, if known.

#### 6. The Health Care Provider (HCP) will:

- · Evaluate the exposure incident.
- Arrange for testing of employee and source individual (if status not already known).
  - · Notify the employee of results of all testing.
  - · Provides counseling and post-exposure prophylaxis.
    - Evaluate reported illnesses.
  - Send written opinion to employer limited to the following:
- Documentation that employee was informed of evaluation results and the need for further follow-up.
  - Whether Hepatitis B vaccine is indicated and if vaccine was received.

#### 7. Employer

- · Receives HCP's written opinion.
- Provides copy of HCP written opinion to employee (within 15 days of completed evaluation).
  - Documents events on
- Employee Accident/Body Fluid Exposure and Follow- Up Form and Employee Medical Record Form.
  - If the exposure incident involved a sharp, a Sharps Injury Log is completed within 14 days.
    - Treat all blood test results for employee and source individual as confidential

Having a written exposure incident plan will help to expedite medical treatment for the exposed person and reduce the chance of infection transmission. Remember time is of the essence because certain post exposure medications are more effective if administered within hours of the incident rather than days. Be sure to locate a health care provider near your practice before an exposure incident happens. It would be wise to prepare a "grab and go" kit of all the forms listed in item 5 of the Sample Exposure Incident Plan. Include a map with turn by turn directions from your parking to the healthcare provider. Assemble all the exposure incident documents in a folder for each employee so it is ready to go.

The next time an exposure incident occurs, from the time you say or hear "OUCH" to the time the exposed person is on their way to the healthcare provider, will be only minutes rather than hours.
